Sub: Declaration of Assets and Liabilities by the Public Servant under section 44 of the Lokpal and Lokayuktas Act 2013 – filing of returns by public servants on or before 15.04.2016.

As per DoPT OM No.407/12/2014-AVD-IV(B) dated 28th March 2016 on the subject cited above, the last date of furnishing of information relating to Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act 2013 as on 1st August 2014 and 31st March 2015 is **15th April 2016**. The annual return as on 31st March 2016 should be filed on or before **31st July 2016**.

The formats to be used for submission of these returns is as per OM No. No.407/12/2014-AVD-IV-B dated 18.03.2015. Hence all the officers / officials of the offices of Pr.AG (G&SSA), PDA (Central) and AG (ERSA) who have not submitted their returns as on 01.08.2014 and 31.03.2015 are directed to submit the Annual Returns of Assets and Liabilities form (Form No.1 to 4) by 12th April 2016.

The officers/officials are also requested to file the Annual Returns for the period 31.03.2016 on or before 15th July 2016.

The soft copy of the form is available both in PDF and word format in our office website viz., www.agkar.cag.gov.in. The PDF format will be taken as the correct form. Officers/officials should check that the forms are as given in the PDF format. The copies of the Annual Returns may also be obtained from Legal Cell also.

There shall be no further extension of the aforesaid last date.
