- ii) Taxes should be shown separately.
- iii) The vendors are requested to visit the office premises (Monday to Friday, 11:00AM to 05:00 PM) to assess the scope of the work and site conditions. Senior Audit Officer (House Keeping) may be contacted to facilitate site inspection.

B. Warranty

The bidder should provide one-year comprehensive, onsite warranty from the date of successful commissioning of the project.

C. Availability of site for project

The site shall be available after issue of work order and the time period for the work shall commence from the date of work order.

D. Time schedule for completion



The supply, installation & commissioning of the CCTV system should be completed within one month of handing over of the site.

E. Subcontract

Successful bidder shall not sub-let, transfer or assign the contract or any part thereof to any agency without written permission of the competent authority of the O/o Pr.AG(G&SSA).

F. Terms of payment

100 percent of the payment shall be released after satisfactory commissioning of the CCTV cameras and infrastructure for the same.

G. Liquidated damages and Penalty

Any unjustified delay in completion of work will render the successful bidder liable for liquidated damages at the rate of 2% of the contract value for every week of delay subject to a maximum of two weeks. Thereafter the O/o Pr.AG (G&SSA) reserves the right to cancel the contract and award the unfinished work to another agency at the risk and cost of the successful bidder.

H. Earnest Money Deposit

Vendors are required to submit Rs. 25,000 (Twenty-five thousand only) towards Earnest Money Deposit along with the bid in the form of a DD drawn in favour of **PAO, IAD, Bangalore** payable at Bangalore. No interest shall be payable on the sum deposited as EMD.

I. Refund of EMD

The EMD of the unsuccessful bidders shall be returned within two weeks of completion of tender process. The EMD of the **successful bidder will be returned** after successful completion of the work.

J. Forfeiture of EMD

The EMD shall be forfeited, if the bidder withdraws or modifies / alters the bid after opening of the bid and during the validity period or if the bidder tries to influence the evaluation process.

K. Validity period of the bid

The bid shall be valid for 90 days. This office reserves the right to issue a part order or complete order for the work. The office may also issue a repeat order for the items under



the same terms and conditions within three months from the completion of initial work order.

L. Last date and time of receipt of bids

As stipulated in the time schedule given at the beginning for submission of bids .

M. Procedure for submission of bids

The bids for components as per **Scope of work** given at **Table A**, should be submitted in **sealed covers** and the covers shall be super scribed with the words “Bid for CCTV Systems”. The cover shall clearly indicate the name, address, Telephone number of the bidder.

N. Bid evaluation

The bids shall be evaluated by a competent purchase committee of the office. The evaluation will be based on the following criteria.

- Track record of executing similar works in the past. The company should have been in the business for at least **three years**.
- Execution of minimum two works of comparable size in the last two years is essential.
- A list of prominent customers may be attached to the bid.
- Quality/specifications of the product, fulfilment of technical specifications, after sales service.
- The office reserves the right to undertake inspection of the works undertaken by the firm in the recent past or to call for feedback from previous clients.
- Copies of licence, registration of the company and other relevant statutory documents.

O. Work Order

On selection of the successful bidder, work order shall be issued accordingly. The specific modalities/work plan of undertaking the work shall then be decided between the office and the successful bidder.
