

INTRODUCTION

This Review Report presents a collective picture of functioning of Forest Divisions in Karnataka during the year 2012-13, bringing out therein delays in receipt of accounts, non-adjustments of balances outstanding under Suspense/Remittances Heads of accounts and other irregularities noticed from the Accounts and during inspection of Divisions, arrears in maintenance of initial accounts, non-clearance of Audit notes, Inspection reports and other reports issued by this office and Principal Accountant General (E&RSA),Karnataka.

With effect from 01-10-2006 Letter of Credit (LOC) system of payment was dispensed with in respect of all Forest divisions.

1.2 This review consists of two parts:

PART – I: Deals with irregularities noticed in the monthly accounts received in this office and other materials such as arrears in annual verification of stock, tools, plants, live-stock etc., in divisions, arrears in realisation of forest revenues and forest offence cases pending.

PART-II: Deals with irregularities noticed during local Audit Inspection of various Divisions.

1.3 Review at Glance covering summary of the points pertaining to Part I and Part II is enclosed at the end of the Report as *Appendix 1*.

1.4 During the year 2012-13 there were 79 Forest Divisions and 24Watershed Divisions which are rendering accounts as detailed below;

PART-I

2.1 **Number of Divisions:** The Treasury system of accounting was introduced by Government from 01-10-2006 replacing the LOC system of drawal of funds and accounting in the Forest Divisions. As a result, the transactions of Forest Divisions takes place through the treasuries and only the residual accounts of Divisions are submitted every month to the Principal Accountant General (A&E).

There were 103 Forest Divisions in Karnataka during 2012-13 and no divisions were formed or closed during the year. Nineteen Divisions which did not furnish the material for the annual report 2012-13 is brought out in **Statement 'A'**.

2.2 **Rendering of monthly accounts:** The monthly accounts containing residual transactions, if any, duly supported by requisite schedules and vouchers are due to the Principal Accountant General (A&E), on or before 8th of the following month except for the month of March, for which the due date is 25th April of each year. The accounts, which were not received by the due date are in **Statement 'B'** delays ranged upto 15 days. Suitable instructions may be given to the Divisions to adhere to the due date for submission of monthly accounts.

No accounts were excluded in the accounting month on account of its non-receipt which is a commendable achievement.

2.3 **Balance outstanding under Remittances Head of Account:**

i) **Forest Remittances: 8782-103-I:** According to para 200 of Karnataka Forest Account Code, the differences noticed every month between the Departmental figures and the Treasury figures are required to be pursued with the concerned Treasuries by the Departmental officers till they are finalized/rectified. There is a balance of Rs.11.59 crores outstanding to the end of 2012-13 (**Statement D-I**).

Accumulation of huge balances under Remittances into Treasuries without prompt verification and reconciliation may lead to cover-up of defalcations. The amount shown as outstanding represents Forest Revenue remitted into treasuries by various divisions of Forest Department but not accounted for in Division/Treasury records. Majority of the amount is outstanding right from 1986-87.

The Government of Karnataka in their Order No.92 TAR 2006, Bangalore Dated 16.09.2006, have stated that the Divisions shall clear the outstanding balances under the head of account 8782-Cash Remittances-103 Forest Remittances. However, it is observed that some of the Divisions have continued to remit the amount under the Head of Account 8782 Cash Remittances-103 - Forest Remittances even after 1st of October 2006 to date, despite, instructions of the Government . Suitable instructions may be issued to the Divisions in this regard.

ii). **Forest Cheques 8782-103-II:** After the Letter of Credit (LOC) system was replaced by drawal and payment through Treasuries from 01-10-2006 cheques are not being issued by the Forest Divisional Officers. However, the divisions have to render the accounts to the Principal Accountant General till the clearance of balances outstanding under Public Account.

There is a debit balance of Rs.0.82 crore outstanding to the end of 31-03-2013 (**Statement D-II**). The debit balance is mainly due to non-cancellation of Forest Cheques remaining unencashed for over one year and also misclassification of Zilla Parishad Cheques under Forest Cheques.

The divisions may be suitably instructed to furnish plus and minus memorandum for the balances outstanding for cheques issued upto 30-09-2006 and clear the balances.

iii) **Inter-Divisional Transfers 8782-103-III :** There is a balance of Rs.249832.96 (credit) outstanding as on 31-03-2013 (Statement-D III). The balance relates to the period from 1973-74 to 1985-86. The Principal Secretary to Government, Forest, Ecology and Environment Department, Bangalore, has been addressed in letter No.FA-I/I/2013-14/14-15 dt: 17-06-2013 to give concurrence for writing-off of the outstanding balances. There are no transactions under this account after 1985-86.

iv) **Book Transfers:** There is a balance of Rs. 77.60 lakh (Dr) outstanding as on 31-03-2013 (Statement D IV). The entire amount of Rs.77.60 Lakh pertains to the period from 1973-74 to 1989-90. There have been no transactions under the above head of account after 1989-90. The Principal Chief Conservator of Forests, Bangalore and the Principal Secretary to Government, Forest, Ecology and Environment Department has also been addressed in No. FA - I/I/ 2013-14/14-15 dated 17-06-2013 for write-off of the balance and their reply is awaited.

2.4 **Forest Advances Outstanding:** The balance of Forest Advances outstanding for recovery upto 31-03-2013 is Rs. 3.69 Crores (debit) as detailed in statement-4 of appendix and the difference between Ledger and Broad Sheet amounting to Rs. 11.22 lakhs continues to prevail since 1973-74 as detailed below:

The Principal Chief Conservator of Forests, Bangalore was addressed to give concurrence to write off the difference amount by deducting the said amount from “8680 Misc Government Account-102” write off from the Head of Account closing to balances, as this un-reconciled balance and its adjustment does not involve any out flow of cash. The matter has also been brought to the notice of the Government for issue of necessary instructions to the Principal Chief Conservator of Forests, Bangalore in this regard. Latest demi-official reminder has been issued in No.FAI/E/2013--14/16-17 dated 21-08-2013 to the Deputy Secretary & Internal Financial advisor, Forest, Ecology & Environment, Multi Storied Buildings., Bangalore to communicate the orders of Government, in this behalf, which is awaited.

2.5 **8443-109-Forest Deposits:** In terms of para 198 and 199 (e) of Karnataka Forest Accounts Code 1976 all the departmental officers are required to furnish plus and minus memorandum along with the deposit schedules while rendering monthly accounts to the Principal Accountant General (A&E), but, it is seen that none of the departmental officers are adhering to the provisions of the code.

Since, Deposits are operated in the treasury payment system the Government may kindly direct the departmental officers to furnish plus and minus memorandum invariably along with the monthly accounts, showing year wise balances.

2.6 **Annual Returns Due to Principal Accountant General (A&E)'s Office:** The Annual returns namely Lapsed Deposit Statements and Clearance Register Extracts have to be sent to the Principal Accountant General's Office before 15th May of every year. The returns for the year 2012-13, due to be received in this office before 15th May 2013, have not been received from the Departmental Officers as detailed in ***Statement 'E'***. The Departmental Officers may be suitably instructed to adhere to the due date in this regard.

2.7 **Arrears of Annual Verification of Stock, Stores, Live Stock, Tools and Plants:** The position of arrears and dates upto which annual verification has been completed and reported by the Department Officers in respect of Stock, Stores, Live -Stocks, Tools and Plants for the year 2012-12 is detailed in the ***Statement- 'F'(FAC-78)*** enclosed.

2.8 **Arrears in realisation (collection) of Forest Revenue:** The Forest Department being major revenue earning department, the necessity for raising demands for Forest Revenue and collection thereof needs to be emphasised. The particulars of Forest Revenue not realised as on 31-03-2013 is furnished in the ***Statement – 'G' (FAC-79)*** based on the material furnished by the Divisions.

It may be seen that the total arrears of Forest Revenue to be realised upto 31-03-2013 is to the extent of Rs. 57.63 Crores. The shortfall in the realisation of Forest revenue results not only in short collections of money due to Government but may also ultimately lead to loss of revenue by way of non-recovery of dues to Government due to efflux of time. Government may issue suitable instructions to the departmental officers concerned regarding the non-collection of dues as all money due to Government fall under section 109 of K.F.C 1963(as if it were an arrear of land revenue).

2.9 **Non-Settlement of Forest Offences/cases by the Departmental Officers:** Forest Offence cases remaining unsettled to end of 31-03-2013 and involving money value to the tune of Rs 5.47 crores as furnished by the Departmental Officers are detailed in the ***Statement- 'H' (FAC-80)***. As several cases relating to very old periods are pending finalisation, Government may issue suitable instructions in this regard to the departmental officers to deal with such cases on priority and ensure their speedy settlement.

Most of the above observations were also made in the earlier reports. Corrective action may have to be taken on priority.

PART-II:AUDIT

The Audit of the Forest divisions is carried out by the Office of Principal Accountant General (ERSA) Karnataka, Bangalore. Salient features of audit carried out during the year 2012-13 are indicated below

- 3.1 The details of Audit notes and Rejoinders issued and outstanding as at the end of 31-03-2013 are shown in ***Statement - I.*** There are 349 Audit notes and 26 Rejoinders issued to the end of 31-03-2013. Suitable instructions need to be issued to the departmental officers to take effective steps for clearance of these items on priority basis.
- 3.2 Inspection Reports and paras outstanding for more than six months have been furnished in ***Statement-II.*** As 396 Reports and 1297 paras are outstanding for the period ending 31-3--2013, suitable instructions may be issued to the Departmental Officers for expeditious settlement of inspection reports and paras.
- 3.3 Money value objections as on 31-03-2013 amount to:
 - (a) Central Audit Rs. 17.98 Crores (***Statement – III A***)
 - (b) Local Audit Rs. 430..73 Crores (***Statement – III B***)

Conclusion:

The Forest Department requires urgently to look into the huge arrears in Forest Remittances, Forest Cheques, Forest Advances, Arrears in realisation of revenue, disposal of Forest Offences/cases and audit objections as pointed in this report.
